### SYSTEM OVERVIEW

This DP/AUTO Script imports third party data from a specifically formatted Excel file into a General Ledger "batch posting option," which can then be edited, printed out for review, edited further and then posted to the accounting system.

This information can come from thirdparty software products or custom applications, which provide a variety of transaction information to be posted to the company's Infinity POWER General Ledger software.

# IMPORT DATA FROM MULTIPLE SOURCES

Data Pro Accounting Software integrates with a wide range of custom and software products. In many cases, we have already developed a specific DP/AUTO interface script for their unique export of their product's information.

However, in the case where there is no standard interface existing, the General Ledger Import Batch Script is ideal in that it allows you to export transactions from an existing product to a CSV or Excel file and then simply decide for yourself which elements of their export file you need to import to the Infinity POWER General Ledger.

Once the installation of the script is completed, a Master Template file will be installed that will now be your guideline to use for setting up General Ledger Import Batch files for DP/AUTO to use to import "Batches" into the Infinity POWER General Ledger module.

Inside this batch, you will be able to allocate to General Ledger accounts, which can be charged to assets, liabilities, operating expenses or any valid General Ledger account in the Chart of Accounts

It will be up to you to make a copy of this template first and then manually copy specific pieces of information from other sources into your new file to prepare it to be used with **DP/AUTO**.

When prepared properly and formatted correctly, **DP/AUTO** will import a **General Ledger Batch** based on the script's defined timing rules into the **Infinity POWER General Ledger** module.

Once it has been imported as a "batch" into the General Ledger module, you can use the Maintain Batches" option to review and make any necessary changes before it is actually posted to the General Ledger.

The software will automatically validate that you have used valid General Ledger account numbers. If not, it will use the "suspense" account configured in the General Ledger's Master Configuration.

Once the fields are mapped, the file is then named and saved as a "csv" file and stored in a specific folder on your PC or network where the **DP/AUTO** script is configured to run periodically.

#### FIND YOUR BATCHES TO EDIT

When the script finds a file in that folder, it will automatically import the file into the **General Ledger Batch** option. The **Batch Edit Report** and its summary below ensures that the "Batch" info is correct before posting. If not, that's why you can edit all batches before they are posted!





## BATCH EDIT REPORT






#### PREVIEW/EDIT BATCHES

Once you choose which batch to edit or preview, the system will display a screen that shows the Amount (debit or credit), Journal #, transaction #, date, and the General Ledger Account Number, that was chosen for it to be posted to.

This is why you post to the **General Ledger Batch** option. Other people within your organization can review what is going to get posted first before anything actually gets posted to the accounting system. Then, corrections can be made prior to the posting of the Batch instead of trying to fix mistakes afterwards.
